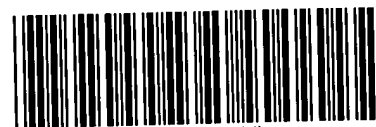

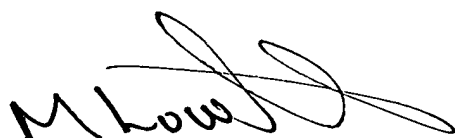
For the year ended 30 September 2015 the Company was entitled to the exemption from audit under section 480 of the Companies Act 2006 relating to dormant companies.

1. Dormant status
