1. Debtors

The Company's records show trade debtors of £105,863. These relate to monies owed from various cottage owners in respect of maintenance/service charges and television licensing. Cottage owners are owed the sum of £104,194 arising from the service charges being invoiced in advance to 31 March 2009. This will be reviewed fully and it is expected that there will be a material vulnerability to set off.

2. Prepayments

The Company's records show pre-payments totalling £872 having been made by the company in relation to TV licensing.

The quantum that may be refunded in respect of this is unknown.

3. Cash at Bank

The Company's records show that £17,302 is currently held in the company's bank account.

4. Trade Creditors

Trade Creditors are recorded in the Company's records at £3,964.

History of Company

In 2005 the trading site was acquired by the shareholder Planning UK Limited. Following acquisition the company undertook a programme of refurbishment of the older units whilst extending the estate through the development of further homes.

The first sales commenced in mid 2006. Completed homes were then sold to private purchaser. Savoy Country Club Limited was responsible for the maintenance of the site.

The management accounts to 5 December 2008 show a profit of £1,797.

On 7 November 2008, Planning UK Limited was placed into administration. The company is not in a position to continue trading without the ongoing support of Planning UK Limited.
