Any creditor, or in the case of any members' voluntary liquidation, any member, in respect of any of the companies or persons listed in Schedule 1 who has an objection to this order, shall have liberty to apply to court to set aside or vary the terms of this order. Any such application shall be made within 42 days from the date of advertisement in the London Gazette, or the notice given in the relevant progress report, whichever is sooner. Such application shall not affect the transfer of the block transfer cases in Schedule 1 until further or other order by the court.
- 8. The replacement officeholder shall give notice to the Secretary of State, the Registrar of Companies in respect of any liquidations and administrations listed in Schedule 1 of the terms of this order as soon as reasonably practicable.
- The outgoing officeholder shall file a copy of this order with each of the courts listed in Schedule
   2.
- 10. Nothing in this order shall release the outgoing officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in Schedule 1.
- 11. The outgoing officeholder shall receive his release as Administrator, for the purposes of paragraph 98 of Schedule B1 to the Insolvency Act 1986, 56 days after the publication in the London Gazette referred to in paragraph 5 above, save that such discharge may be subject to the further order in the event of an application by any creditor or member under paragraph 7 of this order for the specific case subject to that application.
