At the creditors meeting held on 23 August 2011, creditors approved the basis of the Liquidators' remuneration to be by reference to the time properly given by the liquidators and their staff in attending to matters arising in the winding up pursuant to Rule 4 127 of The Insolvency Rules 1986. The current hourly rates of staff and partners involved in this case are as follows Partners £275 - £295 (£270-290), Senior Professional Staff £110 - £230 (£110-220), Assistants and Support Staff £85 - £100. The rates were increased with effect from 1 July 2011, the previous rates are shown in brackets.
