ORDER

BEFORE District Judge Taylor

UPON THE APPLICATION of the Applicant for a block transfer order under Chapter 6 (Sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016 ("Rules")

AND UPON READING the evidence and noting that the proposed replacement office-holders have provided signed consents to the proposed appointments

IT IS ORDERED THAT:

1. Any of the cases listed in the schedules attached to this Order which are proceeding in the County Court are transferred to the High Court of Justice, Business and Property Courts in Bristol solely for the purposes of this Order and thereafter are transferred back to the original court.
2. Any of the cases listed in the schedules attached to this Order which are proceeding in the High Court of Justice, Business and Property Courts of England and Wales or in a Business and Property Courts District Registry (other than at the Business and Property Courts in Bristol) are transferred to the High Court of Justice, Business and Property Courts in Bristol solely for the purposes of this Order and thereafter are transferred back to the original court.

#### Administrator appointments

3. Emma Louise Thompson is removed from her office as administrator of the companies listed in Schedule A attached to this Order with immediate effect.

#### Supervisor appointments

4. Emma Louise Thompson is removed from her office as supervisor of the company voluntary arrangements of the companies listed in Schedule B attached to this Order with immediate effect.
5. Clare Lloyd is appointed as supervisor of the company voluntary arrangements of the companies listed in Schedule B attached to this Order in the place of Emma Louise Thompson with immediate effect.

#### Liquidator appointments

6. Emma Louise Thompson is removed from her office as liquidator of the companies listed in Schedules C, D, E, F, G, H, I, J and K attached to this order with immediate effect.
7. Clare Lloyd is appointed as liquidator of the companies listed in Schedules D, F and I attached to this Order in the place of Emma Louise Thompson with immediate effect.
8. Kevin Ley is appointed as liquidator of the companies listed in Schedules E and J attached to this Order in the place of Emma Louise Thompson with immediate effect.
9. Adam Henry Stephens is appointed as liquidator of the companies listed in Schedule G and K attached to this Order in the place of Emma Louise Thompson with immediate effect.
10. Finbarr Thomas O'Connell is appointed as liquidator of the companies listed in Schedule H attached to this Order in the place of Emma Louise Thompson with immediate effect.

#### Trustee in bankruptcy appointments

11. Emma Louise Thompson is removed from her office as trustee in bankruptcy of the individuals listed in Schedules L, M, N and O attached to this Order with immediate effect.
12. Nigel Ian Fox is appointed as trustee in bankruptcy of the individual listed in Schedule L attached to this Order in place of Emma Louise Thompson with immediate effect.
13. Clare Lloyd is appointed as trustee in bankruptcy of the individual listed in Schedule M attached to this Order in place of Emma Louise Thompson with immediate effect.
14. Henry Anthony Shinnars is appointed as trustee in bankruptcy of the individual listed in Schedule N attached to this Order in place of Emma Louise Thompson with immediate effect.
15. Kevin Ley is appointed as trustee in bankruptcy of the individual listed in Schedule O attached to this Order in place of Emma Louise Thompson with immediate effect.

#### Consequential orders

16. Where in any matter an office holder is as a consequence of this Order appointed jointly with

another, the office holders shall be entitled to act jointly and severally.

17. In respect of any existing court applications or proceedings arising out of any of the matters listed at Schedules A to O of this Order, Emma Louise Thompson shall be removed as a party and (as the case may be) the replacement office holder shall be substituted for Emma Louise Thompson by virtue of this Order and pursuant to Rule 12.37(1)(e) of the Rules.
18. In any case where Emma Louise Thompson is removed from her appointments as an administrator by virtue of this Order she shall be discharged from liability in accordance with paragraph 98(2)(c) of Schedule B1 to the Insolvency Act 1986 with immediate effect.
19. Creditors (and in the case of solvent liquidations, members) shall be given notice of this Order, and the provision for liberty to apply set out herein, by an advertisement in the London Gazette placed within 28 days of the date of the Effective Time.
20. There shall be liberty to each creditor (or in the case of solvent liquidations, each member) to apply to vary or discharge this Order insofar as it relates to the estate of which they are a creditor (or member) within 28 days of the advertisement of this order in the London Gazette.
21. The parties and the replacement office holders appointed by this Order have liberty to apply to amend this Order.
22. The costs of the application shall be borne by Smith & Williamson LLP.
