ORDER

BEFORE District Judge Wales siting at Bristol Civil Justice Centre, Number 2 Redcliff Street, BS1 6GR

UPON THE APPLICATION of the Applicant for a block transfer order under Chapter 6 (Sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016 ("Rules")

AND UPON READING the evidence and noting that the joint office-holders and proposed replacement office-holders have provided signed consents to the proposed appointments

IT IS ORDERED THAT:

- Any of the cases listed in the schedules attached to this Order which are proceeding in the County Court
 are transferred to the High Court of Justice, Business and Property Courts in Bristol solely for the
 purposes of this Order and thereafter are transferred back to the original court.
- 2. Any of the cases listed in the schedules attached to this Order which are proceeding in the High Court of Justice, Business and Property Courts of England and Wales or in a Business and Property Courts District Registry (other than at the Business and Property Courts in Bristol) are transferred to the High Court of Justice, Business and Property Courts in Bristol solely for the purposes of this Order and thereafter are transferred back to the original court.

Administration appointments - Schedule A

3. The Applicant is removed from his office as administrator of the companies listed in Schedule A attached to this Order with immediate effect.

- 4. Christopher Allen is appointed as administrator in substitution of the Applicant in respect of Preston Paving (UK) Limited, details of which appointment are listed in Schedule A, and shall replace the Applicant as the nominated joint-liquidator under the terms of the Administrators' proposals for the purposes of placing the company into creditors voluntary liquidation.
- 5. Yin Lie Lee is appointed as administrator in substitution of the Applicant in respect of the companies which are set out in Schedule A hereto in which she is identified as proposed replacement IP and shall replace the Applicant as the nominated joint-liquidator under the terms of the Administrators' proposals for the purposes of placing the company into creditors voluntary liquidation.

- 23. Creditors (and in the case of solvent liquidations, members) shall be given notice of this Order, and the provision for liberty to apply set out herein, by an advertisement notice in the London Gazette placed within 28 days of the date of the Effective Time.
- 24. There shall be liberty to each creditor (or in the case of solvent liquidations, each member) to apply to vary or discharge this Order insofar as it relates to the estate of which they are a creditor (or member) within 28 days of the advertisement of this order in the London Gazette.
- 25. In each Administration and Company Voluntary Arrangement listed in Schedules A and C respectively where the Applicant is removed from his appointments as an administrator or supervisor by virtue of this Order he shall be released from all liability in respect of his acts and omissions in relation to his conduct as office-holder with effect from 28 days from the date when the relevant notice referred to in paragraph 26 has been placed. In the event that a creditor (or in the case of a solvent liquidation, a member) makes an application pursuant to paragraph 24 of this Order seeking to vary the provisions of this paragraph 25 then the discharge in respect of that company shall take effect from such time as the application is discontinued, dismissed or as may be specified by court order.
- 26. The parties and the replacement office holders appointed by this Order have liberty to apply to amend this Order.
- 27. The costs of the application shall be borne by Evelyn Partners LLP.
