- 1. The insolvency proceedings listed in the Schedules to this order that are not currently before the High Court of Justice, Business and Property Courts of England and Wales, Insolvency and Companies List (ChD) be transferred into this court for the purposes of the Application only and transferred back to their respective courts or hearing centres immediately upon the making of this order
- 2. From the date of this order Gemma Louise Roberts ("the Outgoing Office-Holder") be removed from office:
 - (a) as joint liquidator of the companies in creditors' voluntary liquidation listed in Schedule 1
 - (b) as joint liquidator of the companies in members' voluntary liquidation listed in Schedule 2 and the persons named in those schedules as the proposed appointees shall be appointed to hold the relevant office in place of the Outgoing Office-Holder. For these purposes a proposed appointee does not include anyone so named who is also a current appointee in respect of the same insolvency and who is continuing in office.
- 3. - 11. The creditors in all cases have liberty to apply to set aside or vary this order within 28 days of the date of posting the progress report containing written notice of this order.
- 12. The Applicant shall serve a copy of this order on the Respondents.
- 13. This order having been made without a hearing, any person other than those listed in the paragraph above may apply to set aside or vary this order within 7 days of service upon them.
