No resolution of the board shall be passed unless at least one A Director and one B Director vote in favour of it, save that where the holder of all of the A Shares also holds all of the B Shares and the company only has one director, the sole director may take decisions without regard to any of the provisions of the articles relating to directors' decision-making and in such circumstances the quorum necessary for the transaction of the business of the directors shall be one.
