4 Ultimate holding company

Until 29 May 2008 the ultimate holding company and ultimate controlling company was Product Support (Holdings) Limited, a company incorporated in Great Britain and registered in England and Wales.

On 29 May 2008 the entire share capital of Product Support (Holdings) Limited was purchased by Wincanton Holdings Ltd, a subsidiary of Wincanton Plc incorporated in Great Britain and registered in England and Wales. Consequently Wincanton Plc became the ultimate holding and controlling company of Product Support (Holdings) Limited. The immediate controlling company is Product Support Limited which is also registered in England and Wales.
