
For the year ended 31 August 2023, the company was entitled to an exemption for audit under section 480 of the Companies Act 2006 relating to dormant companies.

1 General information

Miss Daisy's Nursery School Hyde Park Ltd is a private company limited by shares and incorporated in England and Wales. Registered number is 05773323. Its registered office is located at 5th Floor South, 14-16 Waterloo Place, London, England, SW1Y 4AR.

2 Principal accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The functional and presentational currency of the company is GBP Sterling (£). Monetary amounts in these financial statements are rounded to the nearest Pound.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the company's accounting policies. No critical estimates or judgements have been applied to these financial statements.

2.2 Exceptional items

Exceptional items are transactions that fall within the ordinary activities of the company but are presented separately due to their size or incidence.

6 Related party transactions

The company has taken advantage of the exemption, under the terms of section 33 of Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland', not to disclose related party transactions with wholly owned subsidiaries within the group.

7 Controlling party

The company's immediate parent is Dukes Publishing Ltd incorporated in England and Wales. Its ultimate parent undertaking as at year ended 31 August 2023 was Grove Education Partners Holdco Limited incorporated in Guernsey. On 14 September 2023, the ultimate parent undertaking changed to Grove Education Partners Holdings Ltd, also a company incorporated in Guernsey following the insertion of a new top company to the existing group.

This company is considered to have no single controlling party. The smallest and largest entity to prepare consolidated financial statements to include the company is Dukes Education Holdings Limited, a company incorporated in England and Wales.
