# Directors' Annual Report for the period 01/05/2012 to 30/04/2013

The Directors present their annual report and accounts for the year ended 30th April 2013

# Principal activities: -

Pride Sports is a dynamic entrepreneurial community driven organisation, with a focus on annual LGBT multi sports events, leisure activities and year round enabling support for increasing participation in sporting activity by lesbians, gay men, bisexuals, trans people and the wider community

#### Strategic Objectives: -

- To tackle homophobia in sport and promote the inclusion of LGBT people in national sports strategy and delivery in the UK
- To support the growth of a vibrant UK wide LGBT sports community through the development of a national network of LGBT sports organisations
- To deliver and grow the Pride Games sports festival annually and to maintain its position as the UK's premier LGBT multisport festival
- To increase opportunities for participation in sport by LGBT young people, promoting sport as an attractive healthy lifestyle alternative to help enrich individuals' quality of life in the community
- To ensure all projects and activities are inclusive of all sections of the LGBT community and target need where it is greatest, improving the health and well being of LGBT people

The financial report for 01/05/2012 to 30/04/2013 is as shown in the Company Accounts and Balance Sheet recorded at the Pride Sports organisation office and as provided to Companies House for filing as an official statement of the year's completed accounts.

#### Volunteering Contributions: -

Pride Sports is supported by a range of volunteers on an annual basis and this year was no exception. Taking on the delivery of the Football v Homophobia campaign this year, Pride Sports benefitted from the activities of more volunteers than any year previously and Pride Sports Directors also gave significant time voluntarily to the organisation. Pride Sports is hugely grateful to those who worked with us on events that promoted health, well-being, active citizenship and community cohesion through sport.

More than 3000 people benefited in the year 2011-2012 through volunteer events run by Pride Sports Throughout the year Pride Sports worked with organisations in the voluntary and community sector, third sector, charities, not for profit organisations and others to achieve this

#### Funding and Community Development Activities: -

During the year we have continued to have support and help from grant funders, sponsors and donors for our events, using the funding resources to maximum effect. In particular, Pride Sports was involved in a transnational project lead by the European Gay and Lesbian

Sport Federation and funded by the EC Directorate General for Education and Culture funded project "Preventing and fighting homophobic violence in sport – Pride in Sport" EAC-2011-0454

Income was also generated through consultancy both in the development of a community sports festival in Manchester during 2012 and through the drafting of a Toolkit for The FA Consultancy on LGBT participation, community engagement and tackling discrimination was also provided to a range of stakeholders

#### Innovation and Added Value to Local Communities: -

Pride Sports is the UK's only LGBT sports development and equalities organisation. This year has seen the impact of the organisation's work extend significantly, both through the delivery of the Football v Homophobia campaign and the Pride in Sport Project.

Pride Sports Directors have also been consulted by key sports stakeholders nationally on the development of sports provision which is inclusive of lesbian, gay, bisexual and trans people

# Website and New Technology: -

Following the re-launch of the Pride Sports website during 2011/12, Pride Sports has developed a database of LGBT sports provision in the UK and now provides a hub of information not only of Pride Sports' activity, but for LGBT sports groups and networks throughout the UK. Linked to our social media strategy, we have begun to achieve global impact, reaching more individuals and organisations than any previous year.
