ORDER

UPON the application of Dilip Kumar Dattani dated 2 March 2021

AND UPON reading the First Witness Statement of Dilip Kumar Dattani with Exhibit DKD1 dated 1 March 2021

IT IS ORDERED THAT:

- 1 Dilip Kumar Dattani ("the **Outgoing Officeholder**") be removed from office in respect of each of the cases listed in Schedule 1 (attached to this Order) ("**Block Transfer Cases**") from the date of this Order.

- 2 Diana Frangou be appointed as joint replacement officeholder in respect of each of the Block Transfer Cases listed in Part 1 of Schedule 1 from the date of this Order.
- 3 Tyrone Courtman be appointed as joint replacement officeholder in respect of each of the Block Transfer Cases listed in Part 2 of Schedule 1 from the date of this Order.
- 4 The creditors in each of the Block Transfer Cases listed in Schedule 1 be notified of this Order by one composite advertisement in the London Gazette within 14 days of receipt of the sealed Order, and within the body of the report at the time of the next statutory reporting requirement for each case.
- 5 Any creditor, in respect of any of the companies listed in Schedule 1, who has an objection to this Order shall have 28 days from the date of the advertisement in accordance with the preceding paragraph to apply to Court to set aside or vary the terms of this Order. Such application shall not affect the transfer of the Block Transfer Cases listed in Schedule 1 until further or other Order by the Court.
- 6 Following the removal of the Outgoing Officeholder from his offices as liquidator pursuant to paragraph 1 above, the Outgoing Officeholder shall have his release on the date of the Order without being required to (i) apply to the Secretary of State for release or discharge as appropriate pursuant to s173(2)(b) or s174(4)(b) of the Insolvency Act 1986 as the case may be, or (ii) file a receipts and payments account.
- 7 Where in any matter an officeholder is as a consequence of this Order appointed jointly with another, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time being holding office. No functions are required to be undertaken by both joint appointees acting together and no functions are specifically the responsibility of either joint appointee.
- 8 In respect of any existing Court applications or proceedings arising out of any of the matters listed in Schedule 1 of this Order, the replacement officeholder shall be substituted for the Outgoing Officeholder by virtue of this Order and pursuant to Rule 12.37(1)(e) of the Insolvency (England and Wales) Rules 2016.
- 9 The Outgoing Officeholder shall receive his release as liquidator 28 days after the giving of notice to creditors by advertisement in accordance with this Order, save that such release may be subject to further Order in the event of an application by any creditor under paragraph 5 of this Order for the specific case subject to that application.

- 10 The costs of the application shall be borne by RSM Restructuring Advisory LLP.
- 11 The parties have liberty to apply to the Court to amend this Order to include any appointments held by the Outgoing Officeholder which have been inadvertently omitted from the Application.
- 12 The terms of the Order shall not apply to any case which is listed in Schedule 1 but which, prior to the Order being made, is concluded and the case closed.
