AND UPON READING THE DOCUMENTS marked on the Court file as having been read

**IT IS ORDERED:**

- 1      That the cases listed in the Schedules attached to this Order in so far as they are currently proceedings in the County Court or in the High Court be transferred to the Business and Property Courts of England and Wales in Birmingham for the purpose of making the orders listed below.
- 2      That Mr Dix be appointed joint liquidator of the companies listed in Schedule A to this Order in addition to the Applicant with immediate effect.
- 3      That Mr Dix be appointed joint liquidator of the companies listed in Schedule B to this Order in addition to the Applicant with immediate effect.
- 4      That Mr Dix be appointed joint liquidator of the companies listed in Schedule C to this Order in addition to the Applicant with immediate effect.
- 5      That Mr Dix be appointed a joint trustee in bankruptcy of each of the individuals listed in Schedule D to this Order in addition to the Applicant with immediate effect.
- 6      That Mr Dix be appointed a joint Supervisor of the voluntary arrangements of each of the individuals listed in Schedule E to this Order in addition to the Applicant with immediate effect.
- 7      That in relation to any estate over which the Applicant is appointed as a sole office holder which might have been omitted from Schedules A, B, C, D or E to this Order, that the Applicant have permission to restore this application for the purpose of adding Mr Dix as a joint office holder over any such estate.
- 8      That the Applicant do deliver up to Mr Dix access to all the documents, materials and articles which are listed in Schedule F to this Order.

- 9 That Mr Dix do give notice of his appointment to all creditors of the estates listed in the Schedules where a progress report to creditors is due to be circulated within 3 months of the date of this order, as part of the next due progress report.
- 10 That Mr Dix do give notice of his appointment to all creditors of the estates listed in Schedules A, B, C and D of this Order which do not fall under the provisions of paragraph 9 above within 28 days of the date of this Order by way of advertisement in the London Gazette.
- 10 That Mr Dix do give notice in writing by first class post of his appointment to all creditors of the estates listed in Schedule E of this Order which do not fall under the provisions of paragraph 9 above within 28 days of the date of this Order.
- 11 That all creditors of the estates listed in the Schedules to this Order do have permission to apply to the Court, on notice to the Applicant, within 28 days of being given notice of the terms of this Order for the purposes of applying to vary or discharge the Order in so far as it affects the estate or estates of which they are a creditor.
