(B) SUBJECT TO PARAGRAPH (C) BELOW, ON A VOTE ON A RESOLUTION ON A SHOW OF HANDS AT A GENERAL MEETING, EVERY PROXY PRESENT WHO HAS BEEN DULY APPOINTED BY ONE OR MORE MEMBERS ENTITLED TO VOTE ON THE RESOLUTION HAS ONE VOTE. (C) ON A VOTE ON A RESOLUTION ON A SHOW OF HANDS AT A GENERAL MEETING, A PROXY HAS ONE VOTE FOR AND ONE VOTE AGAINST THE RESOLUTION (I) THE PROXY HAS BEEN DULY APPOINTED BY MORE THAN ONE MEMBER ENTITLED TO VOTE ON THE RESOLUTION; AND (II) THE PROXY HAS BEEN INSTRUCTED BY, OR EXERCISES HIS DISCRETION GIVEN BY, ONE OR MORE OF THOSE MEMBERS TO VOTE FOR THE RESOLUTION AND HAS BEEN INSTRUCTED BY, OR EXERCISES HIS DISCRETION GIVEN BY, ONE OR MORE OTHER OF THOSE MEMBERS TO VOTE AGAINST IT. THE TERMS, CONDITIONS AND MANNER OF REDEMPTION OF SUCH SHARES MAY BE DETERMINED BY THE BOARD BEFORE THE SHARES ARE ALLOTTED. WINDING UP: THE COMPANY IS IN LIQUIDATION, THE LIQUIDATOR MAY, WITH THE AUTHORITY OF A SPECIAL RESOLUTION OF THE COMPANY AND ANY OTHER AUTHORITY REQUIRED BY THE STATUTES: (I) DIVIDE AMONG THE MEMBERS IN SPECIE THE WHOLE OR ANY PART OF THE ASSETS OF THE COMPANY AND, FOR THAT PURPOSE, VALUE ANY ASSETS AND DETERMINE HOW THE DIVISION SHALL BE CARRIED OUT AS BETWEEN THE MEMBERS OR DIFFERENT CLASSES OF MEMBERS; OR (II) VEST THE WHOLE OR ANY PART OF THE ASSETS IN TRUSTEES UPON SUCH TRUSTS FOR THE BENEFIT OF MEMBERS AS THE LIQUIDATOR, WITH THE LIKE SANCTION, SHALL THINK FIT

BUT NO MEMBER SHALL BE COMPELLED TO ACCEPT ANY ASSETS UPON WHICH THERE IS ANY LIABILITY.
