UPON the Application of Ian Kings of 19 Catcheside Close Whickham Newcastle upon Tyne NE16 5RX and Allan Keily and Steven Ross, both of RSM Restructuring Advisory LLP, 1 James' Gate, Newcastle upon Tyne, NE1 4AD

AND UPON reading the Witness Statement of Ian Kings dated 30 November 2015

With effect from the date of this Order, IT IS ORDERED that

- The proceedings as listed in the Schedule to this Order be transferred to the High Court of Justice, Chancery Division, Leeds District Registry for the sole purpose of determining this Application upon which they be transferred back to the court from which they were transferred
- 2. Ian Kings be removed from office as Administrator, Liquidator, Trustee in Bankruptcy or Supervisor of the cases listed in the Schedule to this Order ("the Schedule") with immediate effect and be replaced by the individuals listed in the Schedule
- Upon his release, Ian Kings is not required to apply to the Secretary of State for his release from office in accordance with s173(2)(b)(ii), s174(4)(b)(ii) or s299(3)(b) of the Insolvency Act 1986 ("the Act") or file any receipts and payments accounts in relation to any of the cases listed in the Schedule.
- With regards to any of the insolvency estates listed in the Schedule where more than one insolvency practitioner is appointed as officer-holder, the functions of the office holders may be exercised by any or all of the persons appointed.
- If any of the administrations contained in the Schedule for which Ian Kings is being replaced move to creditors' voluntary liquidations in accordance with paragraph 83 of Schedule B1 of the Act and Ian Kings is nominated by creditors to be liquidator under paragraph 83(7)(a) of Schedule B1 of the Act, the replacement administrator as set out in the Schedule will become liquidator

- 6. The provisions of Insolvency Rules 2 47(3A)(Administrations), 6 78A(4)(Bankruptcies), 4 49B(5)(Compulsory Liquidations) and 4.49C(3)(Voluntary Liquidations) shall not apply to any of the cases set out in this Order The period for provision of a progress in each case to which this Order applies shall remain the same as the original date in place prior to this Order having effect.
- The replacement office holders shall arrange for one notice relating to all new appointments to be published in the Gazette within 14 days of receipt of this Order in order to give creditors notice of this Order. The replacement office holders shall also arrange for the filing of any relevant notices in respect of the removal of Ian Kings and their appointment as his replacement with the Registrar of Companies and the Secretary of State for Business Innovation and Skills as appropriate
- 8 Ian Kings shall be discharged from liability as office holder 21 days after the publication of the notice of his removal in the Gazette as provided for in paragraph 7 of this Order.
- 9 Each creditor of the insolvency proceedings listed in the Schedule shall have liberty to apply to vary or discharge this Order within 21 days of the notice being published in the Gazette in accordance with paragraph 7 of this Order
- Subject to paragraph 11, if RSM Restructuring Advisory LLP ("RSM") and/or Baker Tilly Creditors Services LLP ("BTCS") incur any additional costs in the administration of the insolvency estates referred to in the Schedule which are not incurred in the ordinary course of the administration of the estates, these additional costs shall be borne by RSM and/or BTCS and shall not be charged as an expense of any of the insolvency estates listed in the Schedule
- 11. The costs of this Application shall be paid by RSM without recourse to any of the insolvency estates listed in the Schedule
- 12. Notwithstanding paragraphs 10 and 11, the Applicant(s) and the Respondents may

- charge individual insolvency estates for the cost of obtaining an Insolvency Practitioner's licence bond in respect of the relevant insolvency estate; and
- 12.2 equally apportion the cost of publishing the notice in the Gazette in accordance with paragraph 7 between the insolvency estates listed in the Schedule.
- Without incurring any additional expense for any of the said estates, the relevant Applicants, Respondents or Incoming Office-Holders shall notify each creditor of this Application and this Order by way of notice in the next routine report that shall be due to the creditors of each estate, such notice to contain the following matters
 - 13.1 An explanation of the effect of the Order,
 - 13.2. Express reference to the liberty to apply contained in paragraph 12 below;
 - 13.3 In the case of Liquidations and Bankruptcies, where Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that any information which would otherwise be required to be provided under rule 4 108(3) or rule 6.126(2) (as the case may be) of the Insolvency Rules 1986 has not already been provided as part of the report, it is open to that committee to require the relevant Applicants, Respondent or Incoming Office-Holder to provide an account of the administration of the estate, including:
 - 13.4 A summary of receipts and payments,
 - 13.5 A statement that he has reconciled his accounts
 - In the case of Liquidations and Bankruptcies where no Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that such information as aforesaid has not already been provided as part of the report, it is open to any creditor to apply to court for an order that the relevant Applicants, Respondent or Incoming Office-Holder do provide an account of the administration of the estate, including

- 13 7. A summary of receipts and payments;
- 13.8 A statement that he has reconciled his accounts
- Notification that if any Applicant, Respondent or Incoming Office-Holder has been required to provide the information referred to in sub-paragraphs 11 3 and 11.4 above, whether by a Liquidation Committee or by court order on the application of any creditor(s), the costs of any appointed office-holder of so complying will, unless there are good reasons to the contrary, be paid as an expense of the winding up or bankruptcy as the case may be, and
- 13 10 In the case of Liquidations, notification to each creditor of his right under regulation 11(2) of the Insolvency Regulations 1994 to require the appointed office-holders to supply a statement of receipts and payments free of charge
- 13.11 In the case of the Administrations and Voluntary Arrangements, the provision of all such information as might reasonably be required with regard to the conduct of the Administration or Voluntary Arrangement.
- 14. Such further or other order or direction as the court thinks fit
