

For the year to 31 August 2021 the company was entitled to the exemption under Section 480 of the Companies Act 2006 ("the Act") relating to dormant companies.


Directors' responsibilities

Notes to the financial statements for the year to 31 August 2021

1 Accounting policies

The financial statements have been prepared under the historic cost convention and in accordance with the Companies Act 2006 and applicable accounting standards. The financial statements are not prepared on a going concern basis, rather on a break-up basis, as the company has ceased trading.

A summary of the significant accounting policies, which have been applied on a consistent basis, is set out below.

Investments

Investments held as fixed assets are stated at cost less any provision for impairment in value.

Consolidation

The company has taken advantage of the exemption from the requirement to produce consolidated financial statements in accordance with S400 Companies Act 2006 since the company is a wholly owned subsidiary undertaking of a parent company established under the law of an EEA state (Shaw Trust Limited (The), incorporated in the United Kingdom) which itself prepares consolidated financial statements. The financial statements therefore present information about the company as an individual undertaking and not as a group.

The registered address for The Integracja Foundation is ul. Andersa 13, 00-159 Warszawa, Poland.

The investment relates to a 50% membership stake in The Integracja Foundation, a charity registered in Poland, giving Shaw Trust International Partnerships Limited voting rights on the Integracja Foundation Council and Management Board. This membership stake was acquired on 10 December 2007.

The Integracja Foundation recorded a deficit of income over expenditure of £4,879 for the year to 31 August 2021 (2020: deficit of £14,885). It had net assets of £51,589 as at 31 August 2021 (2020: £118,796)
