Results and dividends

The loss for the year amounted to £14,038 (2009 profit of £25,881,776) Dividends of £100,000,000 (2009 £25,900,000) were paid during the year The directors do not recommend the payment of any further dividends

Principal activities and review of the business

The principal activity of the company during the period under review was to hold investments in subsidiaries of the Domino's Pizza Group

Financial instruments

The company's principal financial instruments are intercompany creditors and a bank revolving credit (see note 11 and 12 for further details)

The company has not entered into any derivative transactions such as interest rate swaps or financial foreign currency contracts. The main risks arising from the company's financial instruments are cash flow interest risk, fair value interest rate risk and credit risk. In view of the low level of foreign currency transactions the Board does not consider there to be any significant foreign currency risks.

So far as each person who was a director at the date of approving this report is aware, there is no relevant audit information, being information needed by the auditor in connection with preparing its report, of which the auditor is unaware. Going Concern

The company has an excess of current liabilities over current assets of £123,863,239 at 26 December 2010 (2009 £23,849,201) The directors have carried out a detailed review of the cash flow projections covering 12 months from the approval of these financial statements. The company is dependent on the continued support of its ultimate parent company however the directors are satisfied that the company can generate sufficient cash flow from the existing business to meet its day to day obligations as they fall due. Therefore they continue to adopt the going concern basis of accounting in preparing the annual financial statements.

1. Fundamental accounting concept

The financial statements have been prepared on a going concern basis as the ultimate controlling undertaking and fellow group undertakings have confirmed that they will provide financial support to enable the company to meet its financial obligations, as they fall due

2. Accounting policies

Basis of preparation

The financial statements are prepared under the historical cost convention, and in accordance with applicable accounting standards. The financial statements of DPG Holdings Limited were approved for issue by the Board of Directors on 23 June 2011.

Group accounts

Group accounts are not submitted as the company is exempt under Section 400 (1) of the Companies Act 2006. The results of the company are dealt with in the consolidated accounts of Domino's Pizza UK & IRL plc.

Cash flow statement

The directors have taken advantage of the exemption in Financial Reporting Standard No 1 (revised) from including a cash flow statement in the financial statements on the grounds that the company is wholly owned and its parent publishes consolidated financial statements

Related parties transactions

The company is a wholly owned subsidiary of Domino's Pizza UK & IRL plc, the consolidated accounts of which are publicly available. Accordingly, the company has taken advantage of the exemption in FRS 8 from disclosing transactions with group companies.

Deferred taxation

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at that date that will result in an obligation to pay more, or a right to pay less or to receive more, tax, with the following exceptions

- provision is made for tax on gains arising from the revaluation (and similar fair value adjustments) of fixed assets, and gains on disposal of fixed assets that have been rolled over into replacement assets, only to the extent that, at the balance sheet date, there is a binding agreement to dispose of the assets concerned. However, no provision is made where, on the basis of all available evidence at the balance sheet date, it is more likely than not that the taxable gain will be rolled over into replacement assets and charged to tax only where the replacement assets are sold,
- deferred tax assets are recognised only to the extent that the directors consider that it is more likely than
 not that there will be suitable taxable profits from which the future reversal of the underlying timing
 differences can be deducted

Deferred tax is measured on an undiscounted basis at the tax rates that are expected to apply in the periods in which timing differences reverse, based on tax rates and laws enacted or substantively enacted at the balance sheet date

In his budget of 22 June 2010, the Chancellor of the Exchequer announced Budget tax changes which will have an effect on the company's future tax position. The Budget proposed a decrease in the rate of UK corporation tax from 28% to 24% by 1% each year, from April 2011, which will be enacted annually. The effect on the company of these changes to the UK tax system have been reflected in the financial statements for the year ended 26 December 2010 to the extent which they have been substantively enacted as at 26 December 2010.

The Chancellor also announced in the Budget on 23 March 2011 that the standard rate of UK Corporation Tax will be reduced by a further 1% to 26% from 1 April 2011. This reduction was substantively enacted on 29 March 2011. The future reductions are now planned to take the rate down by 1% per annum to 23% from 1 April 2014 and will be reflected in future accounts following substantive enactment.

Bank revolving facility

Bank revolving facility

On 20 December 2007, the DPG Holdings Limited entered into an agreement to obtain a revolving credit facility from Barclays Bank plc. The limit for this facility is £25,000,000. The balance drawn down by the Company on the facility at 26 December 2010 was £7,750,000 (2009 £7,750,000). The facility has a remaining term of three years and interest is charged at 0.5% per annum above LIBOR. The facility was secured by an unlimited cross guarantee between Domino's Pizza UK & IRL plc, Domino's Pizza Group Limited, DPG Holdings Limited, DP Realty Limited and DP Group Developments Limited as well as negative pledges given by Domino's Pizza UK & IRL plc, Domino's Pizza Group Limited, DPG Holdings Limited, DP Realty Limited and DP Group Developments Limited.

13. Contingent liability

The Group entered into an agreement to obtain bank loans and mortgage facilities. These are secured by a fixed and floating charge over the Group's assets and unlimited guarantee provided by Domino's Pizza UK & IRL plc At 26 December 2010 the balance due under these facilities was £12,034,622 (2009 £12,034,622). The loans bear interest at 0 50% above LIBOR (2009 0 50%). The loan has a term of 7 years and matures on 31 January 2014.
