WRITTEN ORDINARY RESOLUTION

THAT, in connection with a senior facilities agreement (the "Senior Facilities Agreement") proposed to be made between (among others) FirstPort Limited as the company, Knight Square Limited as the parent (the "Parent"), the entities listed therein as guarantors, (i) Pemberton EMMDF II Holdings S.Á R.L., (ii) Pemberton EMMDF II (B) Holdings S.Á R.L., (iii) Pemberton EMMDF II (C) Holdings S.Á R.L., and (v) Pemberton Debt UK Holdings S.Á R.L., and NatWest Markets PIc as mandated lead arrangers, Lucid Agency Services Limited as agent and Lucid Trustee Services Limited as security agent, the members of the Company hereby approve and authorise, for all purposes, the terms of, the arrangements contemplated by, and the execution, delivery and performance by the Company of each of documents listed in schedule 1 attached to these resolutions to which the Company is a party (the "Documents").

THAT notwithstanding any provisions of the Company's articles of association or any personal interest of any of the Company's directors, any one of the directors of the Company, and in the case of any document to be executed as a deed, any two authorised signatories (as defined in section 44(3) of the Companies Act 2006) or any one director in the presence of a witness who attests their signature, be and are hereby empowered, authorised and directed to complete, enter into, execute, deliver and perform the obligations set out in the Documents (in such manner and subject to such amendments, variations and modifications as the Company's directors, in their absolute discretion, think fit (such opinion being evidenced by the execution of such document)).

THAT the execution, delivery and performance of the Documents, with such amendments, variations and modifications as any director of the Company may approve in his absolute discretion, will be for the benefit of the Company for the purpose of carrying on its business and will be most likely to promote the success of the Company for the benefit of its members as a whole.

THAT the Parent be appointed to act as agent of the Company in connection with the Documents.

AND THAT any act done or document executed pursuant to this resolution shall be valid, effective and binding on the Company.

WRITTEN SPECIAL RESOLUTION

THAT the articles of association be amended by inserting the following and amending any relevant numbering accordingly:

*67. RIGHTS OF SECURED INSTITUTIONS IN RESPECT OF SHARE TRANSFERS

(1) Notwithstanding anything contained in these articles, whether expressly or impliedly contradictory to the provisions of this article 67 (to the effect that any provision contained in this article 67 shall override any other provision of these articles), the directors shall not decline to register any transfer of shares, nor may they suspend registration thereof, where such transfer:

- is to any bank, institution or other person which has been granted a security interest in respect of such shares, or to any nominee of such a bank, institution or other person (or a person acting as agent or security trustee for such person) (a "Secured Institution") (and a certificate by any such person or an employee of any such person that a security interest over the shares was so granted and the transfer was so executed shall be conclusive evidence of such facts); or
- (b) is delivered to the Company for registration by a Secured Institution or its nominee in order to perfect its security over the shares; or
- is executed by a Secured Institution or its nominee pursuant to a power of sale or other power existing under such security,

and the directors shall forthwith register any such transfer of shares upon receipt and furthermore notwithstanding anything to the contrary contained in these articles no transferor of any shares in the Company or proposed transferor of such shares to a Secured Institution or its nominee and no Secured Institution or its nominee shall (in either such case) be required to offer the shares which are or are to be the subject of any transfer as aforesaid to the shareholders for the time being of the Company or any of them and no such shareholder shall have any right under the articles or otherwise howsoever to require such shares to be transferred to them whether for any valuable consideration or otherwise. No present or future lien shall apply in respect of any share, dividend or monies payable in respect of any shares mortgaged, charged or pledged in favour of a Secured Institution."
