#### 1 Accounting policies

#### Basis of accounting

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

#### Consolidation

In the opinion of the directors, the company and its subsidiary undertakings comprise a small group. The company has therefore taken advantage of the exemption provided by Section 398 of the Companies Act 2006 not to prepare group accounts.

#### Cash flow statement

The company has taken advantage of the exemption in FRS 1 "Cash flow statements" (revised 1996) from including a cash flow statement in the financial statements on the grounds that the company is small

#### **Deferred taxation**

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at that date that will result in an obligation to pay more tax, or a right to pay less tax, or a right to receive repayments of tax

Deferred tax assets are recognised only to the extent that the directors consider it more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted. Deferred tax assets and liabilities recognised have not been discounted.

Deferred tax is measured on a non discounted basis at the average tax rates that are expected to apply in the periods in which timing differences reverse, based on tax rates and laws enacted or substantively enacted at the balance sheet date

#### Financial instruments

Financial instruments are classified and accounted for as financial assets, financial liabilities or equity instruments, according to the substance of the contractual arrangement

Financial instruments which are assets are stated at cost less any provision for impairment Financial liabilities are stated at principal capital amounts outstanding at the period end. Issue costs relating to financial liabilities are deducted from the outstanding balance and are amortised over the period to the due date for repayment of the financial liability.

An equity instrument is any contract that evidences a residual interest in the assets of the company after deducting all of its liabilities. A financial liability is any contractual arrangement for an entity to deliver cash to the holder of the associated financial instrument.

If a financial instrument contains both an equity and a liability element, then the liability element is first established with any residual value being disclosed within equity shareholders' funds. The liability element is the present value of the future payments guaranteed to be made to the holders of the financial instrument.

Non-discretionary dividends payable are disclosed within interest in the company's profit and loss account

Included within other creditors as at 31 December 2012 are £25,000 (2011 £25,000) of redeemable preference shares carrying a fixed cumulative dividend. These preference shares are redeemable at par on 17 January 2013 by the company. As at 31 December 2012 the company had arrears of £17,871 (2011 £14,871) in relation to the fixed cumulative dividend carried by these preference shares. The company has not historically paid dividends on the preference shares, and as such the arrears date cumulatively from the date of issue of the preference shares, being 17 January 2007.

#### 5. Related party transactions

At the year end the company owed £970,677 (2011 £513,885) to Martel Instruments Limited, a wholly owed subsidiary of Martel Instruments Holdings Limited

At the year end the company was owed £41,593 (2011 £41,593) by Martel Employee Benefit Trust, a wholly owed subsidiary of Martel Instruments Holdings Limited

There is a cross guarantee between Martel Instruments Limited and Martel Instruments Holdings Limited with Yorkshire Bank

Included within legal and professional fees is £25,000 (2011 £25,000) relating to amounts paid to Tannswell Limited, a company in which J M Finlan is a director, in respect of his role as chairman and non executive director of the company

Included within legal and professional fees is £20,000 (2011 £20,000) relating to amounts paid to Maven Capital Partners UK LLP in respect of M Collis as a non executive director of the company
