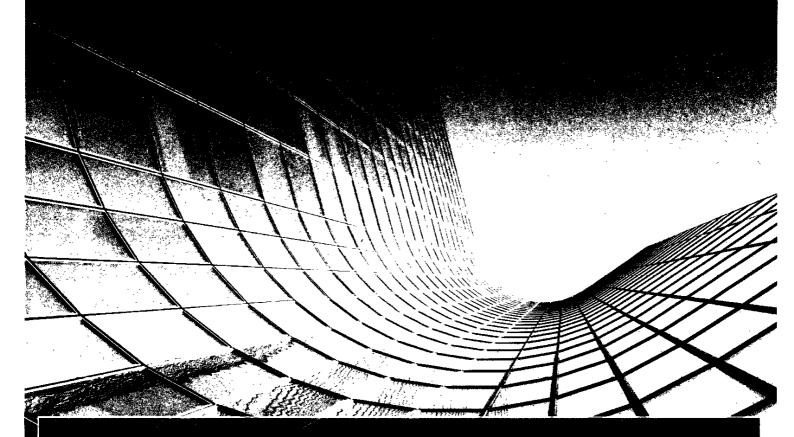

Progress to date

- 2.1. The receipts and payments account attached in Appendix I details the asset realisations during the period of this report.
- 2.2. Following the submission of the Company's pre-liquidation Corporation Tax returns it was determined that a Corporation Tax refund of £11,439.07 was due to the Company from HM Revenue & Customs ("HMRC"). As the Company did not operate a bank account the refund was distributed in specie to the Company's shareholder on 15 January 2018.
- 2.3. HMRC has confirmed that there are no tax liabilities outstanding on the Company, it does not intend to open any enquiries into the Company's tax affairs and it has no objection to the closure of the liquidation.

3. Joint liquidators' remuneration

- 3.1. The remuneration of the joint liquidators has been fixed as follows:
 - That the remuneration of the joint liquidators be fixed by reference to the time properly given by the joint liquidators and their staff in attending to matters arising in the winding up (pre and post appointment), without further resolution from the members.
- 3.2. In the period ended 19 April 2018, time costs of £7,508.50 were incurred over 27.35 hours at an average rate of £275 per hour, including the time costs incurred prior to the commencement of liquidation.
- 3.3. The time costs were incurred primarily as a result of pre liquidation planning, preparation and review of the documents required to place the Company into liquidation, dealing with VAT
