#### INTRODUCTION

Laser Hotels One Limited (Entity) entered members' voluntary liquidation on 13 September 2019. Emma Cray and Steven Sherry were appointed joint liquidators of the Entity (Liquidators).

This is the Liquidators' final account of the liquidation and covers the period from 13 September 2019 to 25 January 2022. For the purposes of the summary receipts and payments account (at Appendix A), the Liquidators also set out what has been received and paid in the period since their last progress report, being from 13 September 2021 to 25 January 2022 (the Period). You may also refer to the Liquidators' previous progress reports for the period from 13 September 2019 to 12 September 2021.

The statutory information relating to the Entity and the Liquidators is at Appendix B.

#### REPORT ON THE LIQUIDATION

#### **Realisation of assets:**

As previously reported, the Liquidators took control of the assets listed in the directors' Declaration of Solvency.

#### Investments

The Entity has three subsidiaries in members' voluntary liquidation valued at £1,104. These investments were noted on the directors' Declaration of Solvency for these subsidiaries.

As previously reported, the Entity has received total distributions of £1,102 from its subsidiaries. These distributions comprised of the assignment of intercompany balances owed by the Entity and the distributions had the effect of offsetting the creditor balances owed to its subsidiaries.

#### Intercompany balances

The intercompany balance of £1,1117 was owed from the parent company, LSREF3 Laser (Mercure) Limited. As the Entity owed the parent company £9, automatic set off applied. Therefore, actual realisations of the intercompany balance totalled £1,108

The Liquidators have not identified any additional assets of the Entity in the Period and are not aware of any other assets that remain to be realised.

#### **Settlement of liabilities:**

The directors' Declaration of Solvency indicated that the Entity had an outstanding liability upon entering liquidation, being inter-company creditors.

As previously reported, all claims were settled as follows:

- £1,102 due to subsidiaries: these extinguished upon receipt of the distribution from the subsidiaries;
- £9 due to parent company: automatic set off applied to this balance given the intercompany debtor was due from the parent company; and
- £5 due to two other group companies: assignment of a book debt owed by the parent company.

All the intercompany creditors waived their right to statutory interest.

As previously reported, the Liquidators published a notice in the London Gazette inviting creditors to submit details of claims they may have against the Entity. The Liquidators have not received any claims in the liquidation. However, the liquidation remained open as the Liquidators had received a claim against the Entity's subsidiary which was pending resolution, the claims have now been resolved, therefore, the Liquidators will proceed to close the liquidation.

#### **HM Revenue & Customs ("HMRC"):**

As previously reported, HMRC have confirmed that the Entity has no outstanding tax liabilities and that they have no objection to the liquidation being closed.

#### **Distributions to Members:**

On 9 September 2021 an in-specie distribution of £1,103 (representing £1 per share) was made to the Member of the Entity. The distribution consisted of inter-group debtor balance together with any other assets held by the Entity.

The value attributed to the distribution was based on the value at which the assets were held in the Entity's books.

#### LIQUIDATORS' FEES AND EXPENSES

#### **Basis of remuneration**

The basis of the Liquidators' remuneration has been fixed by reference to the time properly given by them and their staff in dealing with the liquidation, in accordance with a resolution dated 13 September 2019.

#### Liquidators' remuneration and expenses

Fees and expenses of the liquidation have been paid to PricewaterhouseCoopers LLP by another group company under a separate contractual arrangement. There is no recourse to the liquidation estate.

We have separately provided the member with the information required in accordance with Statement of Insolvency Practice 7.

#### Members' rights regarding the Liquidators' remuneration and expenses

Any member of the Entity with permission of the court or members of the Entity with at least 5% of the total voting rights of all the members having the right to vote at general meetings of the entity (or permission of the court) are entitled to request further information about our fees and expenses.
