UPON THE APPLICATION by a Claim Form dated 18 June 2014 of Laurence Peter Goodman the Claimant and director of above named Destrim Limited (hereinafter called "the Company")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the Evidence of Service of Gareth Hegarty and the exhibit thereto

AND the Claimant undertaking that

- (A) the Company will not carry on business or operate in any way other than to take the necessary steps to pursue the compensation claim referred to in paragraph 22 of the Witness Statement of Laurence Peter Goodman dated the 9 June 2014.
- (B) he will notify the Registrar of Companies of the title and Court reference of the said proposed litigation immediately after issue.
- (C) he will inform the Registrar of Companies immediately on the conclusion of the said proposed litigation or any appeal therefrom or the conclusion of the claim by any other means.

- (D) he will if the Company is successful in the said proposed litigation distribute the monies awarded by the Court according to law
- (E) a director of the Company will immediately on the expiry of 3 months from the conclusion of the said proposed litigation or any appeal therefrom or the conclusion of the claim by any other means and the distribution of any award by the Court, apply to the Registrar of Companies for the voluntary strike off of the Company under Section 1003 of the Companies Act 2006 and comply with all the relevant requirements for such an application
- (F) he will unless the said proposed litigation is completed in the interim, at 6 monthly intervals from the date of the order serve on the Registrar of Companies a full and sufficient Witness Statement setting out what steps have been taken to progress the said proposed litigation

AND UPON the solicitors for the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED that


- (1) the name of the above named Destrim Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 05899359 Limited
- (3) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck off



- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (5) in the event that the Claimant fails to comply with undertaking (F) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimant
- (6) the Claimant do pay the Registrar of Companies his costs of the said Application in the agreed sum of £300-00
