#### Assets/Liabilities

The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed an intercompany debt of £100 due from Tesco Purple (GP) Limited, investments of £1 in Tesco Purple (Nominee 1) Limited and £1 in Tesco Purple (Nominee 2) Limited together with intercompany debts of £1 due to Tesco Purple (Nominee 1) Limited and £1 due to Tesco Purple (Nominee 2) Limited

A distribution of £1 was received from the liquidation of Tesco Purple (Nominee 1) Limited which was off set against the debt of £1 due by the Company to Tesco Purple (Nominee 1) Limited A distribution of £1 was also received from the liquidation of Tesco Purple (Nominee 2) Limited which was off set against the debt of £1 due by the Company to Tesco Purple (Nominee 2) Limited

A search of the Index of Proprietor's Names at HM Land Registry proved negative

#### Creditors

A notice to creditors to prove their claims in the liquidation was advertised in The London Gazette on 20 November 2013. No creditors were forthcoming as a result of this advertisement

## Tax/VAT/PAYE

The company was deemed dormant for corporation tax purposes. At the request of the joint liquidators, HM Revenue & Customs ("HMRC") confirmed that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the liquidators convening a final meeting of members to conclude the liquidation.

A similar assurance was sought and received from HMRC in respect of VAT and PAYE matters.

#### **Distributions**

On 20 February 2014 the joint liquidators declared a first and final distribution of the assets of the Company to Tesco Purple (GP) Limited, as the sole shareholder of the Company

The distribution was at the rate of £1 per £1 ordinary share and was effected by set off against the debt of £100 due to the Company by Tesco Purple (GP) Limited

# Joint liquidators' remuneration and expenses

A written resolution was passed on 11 November 2013 that the remuneration of the joint liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company

The liquidators' remuneration will be paid by another group company and accordingly no detailed analysis is included in this report
