



- an intra-group loan agreement (the "Intra-Group Loan Agreement") proposed to be entered into between each member of the Group (as borrowers) (each a "Borrower") and each member of the Group (other than the Purchaser) (as lenders) (each a "Lender"), and
- a corporate guarantee (the "ABL Guarantee") proposed to be entered into by CCHL and each other member of the Group in favour of Landsbanki CF
