- The cases set out in the Schedules hereto and referred to as being in the county court or (if appropriate) being cases in a District Registry ("the other courts") be transferred to the Companies Court for the purpose of this Application and be transferred back upon the making of this Order
- In relation to the administration of The Epsom Legion Club Limited identified in Schedule A to this order, Julie Patricia Vahey be removed as the Joint Administrator and Grant Lane Pegg be appointed in her place
- In relation to the bankruptcies identified in Schedule B to this order, Julie Patricia Vahey be removed as the Joint Trustee and Grant Lane Pegg be appointed in her place
- In relation to the creditors' voluntary liquidations identified in Schedule C to this order, Julie Patricia Vahey be removed as the Joint Liquidator and Grant Lane Pegg be appointed in her place
- In relation to the members' voluntary liquidation identified in Schedule D to this order, Julie Patricia Vahey be removed as Joint Liquidator and Grant Lane Pegg be appointed as Joint Liquidator in her place
- In relation to the compulsory liquidation of New Generation Power Limited identified in Schedule E to this order, Julie Patricia Vahey be removed as the Joint Liquidator and Grant Lane Pegg be appointed as Joint Liquidator in her place
- Julie Patricia Vahey be released from liability in the administration and otherwise in relation to her conduct as office holder of the companies and individuals as are listed in the Schedules hereto from 56 days after the relevant notice referred to in paragraph 10 below has been given to the creditors of the relevant estate, save in respect of any claim notified to Julie Patricia Vahey or (where appropriate) her joint appointee or replacement office holder by that date
- In respect of all matters set out in the Schedule to this order there shall be no requirement for progress reports or receipts and payments accounts to be prepared or filed by virtue of Julie Patricia Vahey vacating office in accordance with this order. For the avoidance of doubt the provisions of Rules 2 47(3A), 6 78(A)4, 4 49B(5) and 4 49(C) CVL(3)(a)-(b) shall not apply in respect of the matters which are the subject of this order.
- Each creditor and, in the case of the members' voluntary liquidations, each member, shall have permission to apply to vary or discharge this order in whole or in part within 28 days of being given notice of it under paragraph 10 below
- Where the Insolvency Act 1986 or the Insolvency Rules 1986 require the substitution of Julie Patricia Vahey to be advertised, the Applicant shall procure that, at the first convenient opportunity to do so, and in any event within 3 months of the date of this Order, the block advertisement in relation to each of

the estates shall be placed in the London Gazette containing notification of the following matters

- a) the substitution of Julie Patricia Vahey and details of the substitution,
- b) the fact that creditors have liberty to apply, within 28 days after the notice has been advertised, to vary or discharge the order made,
- c) in the case of each bankruptcy and liquidation, that
 - the cost of complying with a request of the committee or creditor for an account of Julie Patricia Vahey's administration should be an expense of the insolvency proceedings,
 - the fact that the creditors have the right to object and make representations to the Secretary of State in respect of the release of Julie Patricia Vahey within 28 days after the notice has been advertised,
 - the fact that Julie Patricia Vahey will be entitled to apply to the Secretary of State for her release within 42 days after the notice has been advertised
- As soon as reasonably practicable, the Applicant shall lodge with each of the other courts one copy of this Order for each case under the jurisdiction for filing on the respective court file
