1 Accounting policies

Company information

Cockerels Woods at Leeds New Forest is a private company limited by guarantee incorporated in England and Wales. The registered office is Old Linen Court, 83-85 Shambles Street, Barnsley, South Yorkshire, S70 2SB.

1.1 Accounting convention
