Business review and future developments

On 9 October 2006 the company was incorporated with the name of Precis (2655) Limited. Subsequently on 20 December 2006 the company changed its name to Wittington Investments (Next Wave) Limited. These accounts cover the period from incorporation to 15 September 2007.

The profit and loss account for the period is set out on page 4. The loss on ordinary activities after tax amounted to £101,551.

No dividend is recommended for the period.

We have audited the financial statements of Wittington Investments (Next Wave) Limited for the period ended 15 September 2007 which comprise the profit and loss account, the balance sheet and the related notes. These financial statements have been prepared under the accounting policies set out therein.

1 Accounting reference date

The accounting reference date of the company is the Saturday nearest to 15 September. Accordingly, these financial statements have been prepared to 15 September 2007. These accounts cover the period from incorporation to 15 September 2007.

2 Accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards.

Wittington Investments Limited has provided the company with an undertaking that it will continue to make available such funds as are needed by the company until the presentation of financial statements for the 52 weeks ended 13 September 2008. This should enable the company to continue in operational existence for the foreseeable future by meeting its liabilities as they fall due for payment. As with any company placing its reliance on other group entities for financial support, the directors acknowledge that there can be no certainty that this support will continue although, at the date of approval of these financial statements, they have no reason to believe that it will not do so.

Under Financial Reporting Standard 1 (revised) the company is exempt from the requirement to prepare a cash flow statement on the grounds that it is a wholly owned subsidiary undertaking. A group cash flow statement is included in the financial statements of Wittington Investments Limited.

Under Financial Reporting Standard 8 the company is exempt from the requirement to disclose transactions with entities that are part of the group headed by Wittington Investments Limited, as 90% or more of the voting rights of the company are controlled within that group and the company was included in the consolidated financial statements of the group, which are publicly available.

The company is exempt by virtue of s228 of the Companies Act 1985 from the requirement to prepare group accounts.

3 Operating costs

No charge was made during the period in respect of auditors' remuneration. The auditors' remuneration is borne by the parent company.

The directors received no emoluments in respect of their services to the company.
