**UPON THE APPLICATION OF STEPHEN ROBERT CORK** (whose contact details are Cork Gully LLP, 6 Snow Hill, London, EC1A 2AY, StephenCork@corkgully.com and whose address for service is Pinsent Masons LLP, 30 Crown Place, Earl Street, London EC2A 4ES) made in his capacity as joint liquidator, administrator and trustee in bankruptcy (as applicable) in respect of the matters listed in the Schedule hereto by notice dated 27 November 2019

**AND UPON READING** the documents recorded on the Court file as having been read

**AND UPON READING** the statement of Anthony Malcolm Cork (of Cork Gully LLP, 6 Snow Hill, London, EC1A 2AY, AnthonyCork@corkgully.com) that he is an insolvency practitioner qualified to act and consents to so act in accordance with the terms of this Order.

**IT IS ORDERED THAT:-**

**1. TRANSFER BETWEEN COURTS**

- 1.1 The cases set out in the Schedule hereto and referred to as being in the County Court be transferred to the High Court pursuant to Rule 12.37(1)(a) of the Insolvency (England and Wales) Rules 2016.

**2. REMOVAL OF JOANNE ELIZABETH MILNER AS OFFICE HOLDER**

- 2.1 Joanne Elizabeth Milner be removed as office holder in the cases set out in the Schedule hereto pursuant to the relevant power set opposite each category below, with effect from the date of this Order:-

- 2.1.1 Creditors' voluntary liquidation cases - Section 108 of the Insolvency Act 1986 and Rule 12.36(2)(a) of the Insolvency (England and Wales) Rules 2016;
- 2.1.2 Members' voluntary liquidation cases - Section 108 of the Insolvency Act 1986 and Rule 12.36(2)(a) of the Insolvency (England and Wales) Rules 2016;
- 2.1.3 Compulsory winding up case – Section 172(2) of the Insolvency Act 1986 and Rule 12.36(2)(a) of the Insolvency (England and Wales) Rules 2016;
- 2.1.4 Administration cases – Paragraph 88 of Schedule B1 to the Insolvency Act 1986 and Rule 12.36(2)(b) of the Insolvency (England and Wales) Rules 2016;
- 2.1.5 Bankruptcy cases – Section 298 of the Insolvency Act 1986 and Rule 12.36(2)(c) of the Insolvency (England and Wales) Rules 2016.

**3. APPOINTMENT OF REPLACEMENT OFFICE HOLDER**

- 3.1 *Anthony Malcolm Cork, having filed a statement with the Court that he is qualified to act as an insolvency practitioner in the relevant cases and that he consents to act, be appointed in substitution for Joanne Elizabeth Milner as joint office holder (namely joint administrator, liquidator and trustee in bankruptcy (as applicable)) with Stephen Robert Cork for the matters set out in the Schedule from the date of this Order.*
- 3.2 Any act required or authorised under any enactment to be done by a liquidator, an administrator or a trustee in bankruptcy (as applicable) may be done by all or any one of the respective liquidators, administrators or trustees in bankruptcy (as applicable) in each relevant matter acting jointly or alone.
- 3.3 In the cases where Joanne Elizabeth Milner is being replaced in the office of administrator, Anthony Malcolm Cork shall additionally replace her as the nominated liquidator where and to the extent that Joanne Elizabeth Milner is referred to as the nominated liquidator for any future liquidation in the relevant administrators' proposals which have been approved by creditors.

**4. ADVERTISEMENT, REPORTING TO CREDITORS AND MEMBERS AND RELEASE**

- 4.1 As soon as reasonably practicable, and in any event within 28 days of the date of this Order, the Applicant shall procure that a block advertisement is placed in the Gazette. The advertisement shall contain notification of the removal of Joanne Elizabeth Milner from the cases identified in the Schedule hereto and the appointment of Anthony Malcolm Cork in her place and shall be in substitution for notifying each individual creditor or member (as applicable) on each estate, save to the extent provided for at paragraph 4.2 below.
- 4.2 The Applicant shall at the first convenient opportunity, and in any event when the next routine report is due to the creditors or members (as applicable) of each estate or within twelve months following the making of this Order, whichever is sooner, notify such creditors or members of the making of this Order, such notice to contain the following matters:-
- 4.2.1 an explanation of the effect of this Order; and
- 4.2.2 express reference to the liberty to apply contained in paragraph 5 below.
- 4.3 *In relation to the cases listed in the Schedule hereto, insofar as there is any requirement for any appointment or removal of an office holder to be advertised, the requirement shall be dispensed with save to the extent provided for in paragraph 4.1 above.*
- 4.4 The Applicant and the Respondents be authorised to dispense with any requirement to file a progress report or a receipts and payments account in any of the cases set out in the Schedule hereto as a consequence of the removal and the replacement of Joanne Elizabeth Milner as an office holder, and the Applicant and Anthony Malcolm Cork to file progress reports or receipts and payments accounts (as applicable) in the normal way.
- 4.5 Joanne Elizabeth Milner shall be granted her release as administrator from the 29th day after the publication in the Gazette referred to in paragraph 4.1 above, and otherwise on application to the Secretary of State to be made not earlier than the said 29th day.

**5. LIBERTY TO APPLY TO THE COURT**

- 5.1 There be liberty to each creditor or member (as applicable) of each estate set out in the Schedule hereto to apply to vary or discharge this Order within 28 days of receipt of the notices directed to be sent under paragraph 4.2 above.

**AND IT IS HEREBY FURTHER ORDERED:-**

**6. TRANSFER BETWEEN COURTS**

- 6.1 The cases set out in the Schedule hereto as being in the County Court be transferred back to the relevant County Court as set out in the Schedule, adopting the same case

numbers as were used immediately prior to the transfer to the High Court hereto, pursuant to Rule 12.37(1)(b) of the Insolvency (England and Wales) Rules 2016.

7. **SERVICE**

- 7.1 Service of the Application be dispensed with.
- 7.2 The Order be served on the Secretary of State to whom there be express liberty to apply.
- 7.3 The Applicant file any appropriate notices in respect of the removal of Joanne Elizabeth Milner and the appointment of Anthony Malcolm Cork in accordance with this Order with *the Registrar of Companies within the prescribed times or otherwise within a reasonable period from the date of this Order.*

8. **COSTS**

- 8.1 The costs of this Application be borne by Cork Gully LLP.
