



**FINAL ACCOUNT**

I write further to my appointment as liquidator of the above Company at a members' meeting held on 24 June 2021.

I am writing to advise you that I am now in a position to close this liquidation, and I attach my final account.

**Liquidator's actions since appointment**

The purpose of the liquidation was to conclude the Company's affairs in an orderly manner, and distribute surplus capital to the members of the Company.

**Receipts and payments**

My Receipts and Payments Account for the period covered by this report is attached at **Appendix 1**. There were no cash transactions in the liquidation.

Non-cash transactions are as indicated below.

**Creditors' claims**

Notice to creditors to submit claims was duly advertised in the London Gazette on 30 June 2021. No claims have been received.

**HMRC**

HMRC were notified of my appointment. Corporation tax returns for all pre-liquidation periods were lodged with HMRC by the Teledyne Group. Corporation tax of £6,625.87 was paid by Teledyne UK Limited.

The Company had been part of the Teledyne UK Limited VAT Group, but was removed prior to the commencement of the liquidation.

I applied for formal tax clearance to conclude the liquidation. This has been received. I have responded to all information requests received, and have not been notified by HMRC of any outstanding tax issues preventing the closure of the liquidation.

## Distributions

The following transactions are deemed to have been executed in the liquidation:

- An inter company debt of £6,626.88 was repaid by Teledyne UK Limited;
- A capital distribution of £1.01 was declared and paid to the sole member of the Company, Teledyne UK Limited.

## Liquidator's remuneration and expenses

My remuneration was previously authorised by members at a meeting held on 24 June 2021 on a fixed fee basis of £2,750 plus VAT. This sum has been billed to Teledyne UK Limited and settled in full.

In the liquidation period expenses of £282.50 plus VAT where applicable have been incurred, as set out below:




