ORDER

UPON the Application of MR PHILLIP RODNEY SYKES, formerly of Moore Stephens LLP 150 Aldersgate Street, London, EC1A 4AS dated 7 January 2015

And UPON READING the documents on the Court File recorded as having been read including the witness statement and exhibit of MR PHILLIP RODNEY SYKES dated 7 January 2015

IT IS ORDERED THAT:-

- 1 The persons identified as "joint administrators" in Schedules 1-5 to this Order be joined as Applicants pursuant to Rule 7 10C(5) of the Insolvency Rules 1986 ("the Rules")

- 2 Where the Respondent(s) are appointed as joint liquidator or joint administrator, as the case may be, the joint liquidator or joint administrator as the case may be, have the power to act jointly and severally so that all functions may be exercised by any or all of them
- 3 That the Applicant has leave to make a composite application in respect of the insolvency proceedings identified in the Schedules numbered 1 to 37 attached to this Order (the "Schedules")
- 4 That the proceedings listed in the Schedules be transferred to the Companies Court of the Chancery Division of The Royal Courts of Justice for the purpose only of the Application pursuant to the Court's discretion under Rule 7 10D(2)(a) of the Rules, and the Applicant does ensure that a sealed copy of this Order be lodged with the court having jurisdiction over each case affected by such order for filing on the court file relating to that case

- 6 That the time for service of the Application be abridged
- 7 The Applicant, **MR PHILLIP RODNEY SYKES**, be removed from his office as joint administrator of the companies listed in Schedules 1-5 hereto as being in administration

- 13 The First and Fifth Respondents, **MR JEREMY MARK WILLMONT** and **MR STEPHEN ANTHONY RAMSBOTTOM** respectively, shall be appointed as trustees in bankruptcy of the individuals listed in Schedule 7 hereto, in substitution of the Applicant, **MR PHILLIP RODNEY SYKES**
- 14 The Applicant, **MR PHILLIP RODNEY SYKES**, be removed from his office as joint trustee in bankruptcy of the individuals listed in Schedule 8 hereto

- 15 The First Respondent, **MR JEREMY MARK WILLMONT**, shall be appointed as joint trustee in bankruptcy of the individuals listed in Schedule 8 hereto, in substitution of the Applicant, **MR PHILLIP RODNEY SYKES**

- 39 The Applicant, **MR PHILLIP RODNEY SYKES**, be removed from his office as joint liquidator of the company identified in Schedules 33 - 37 hereto, as being subject to Compulsory Liquidation

- 40 The Second Respondent, **MR WILLIAM GUY BEACH**, shall be appointed as joint liquidator of the companies identified in Schedule 33 hereto, as being subject to a Compulsory Liquidation, in substitution of the Applicant, **MR PHILLIP RODNEY SYKES**
- 41 The Seventh Respondent, **MS EMMA SAYERS**, shall be appointed as joint liquidator of the companies identified in Schedule 34 hereto, as being subject to a Compulsory Liquidation, in substitution of the Applicant, **MR PHILLIP RODNEY SYKES**
- 42 The First Respondent, **MR JEREMY MARK WILLMONT**, shall remain in office as the sole liquidator of the companies listed in Schedule 35 hereto as being in Compulsory Liquidation
- 43 The First Respondent, **MR JEREMY MARK WILLMONT**, shall be appointed as the joint liquidator of the companies listed in Schedule 36 hereto as being in Compulsory Liquidation in substitution of the Applicant, **MR PHILLIP RODNEY SYKES**
- 44 The First Respondent, **MR JEREMY MARK WILLMONT**, shall be appointed as the joint liquidator of the companies listed in Schedule 37 hereto as being in Compulsory Liquidation, in substitution of the Applicant, **MR PHILLIP RODNEY SYKES**
- 45 The Applicant be released from all liability both in respect of all his acts and omissions in the administration of his cases and otherwise in relation to his conduct as office holder of the companies and individuals as are listed in the Schedules hereto
- 45 1 by the creditors of the relevant estates, with effect from 28 days after the relevant notice referred to in paragraph 46 below has been given to creditors,
- 45 2 by the Secretary of State, with effect from 42 days after the relevant notice referred to in paragraph 46 below has been advertised,
- save where a creditor or the Secretary of State notifies the Applicant or (where appropriate) his joint appointee or replacement office holder of any claim, whereupon the time period for such release shall be the final resolution of such purported claim
- 46 The Applicant shall not be required to produce any progress reports on ceasing to act as office holder pursuant to this Order
- 47 Where the Insolvency Act 1986 (the "Act") or the Rules require the substitution of the Respondents in place of the Applicant to be advertised, the Applicant shall procure that, at the first convenient opportunity to do so, and in any event within 3 months of the date of this Order, a block advertisement in relation to each of the estates shall be placed in the London Gazette containing notification of the following matters
- 47 1 the substitution of the Respondents in place of the Applicant,
- 47 2 the fact that the creditors have liberty to apply, within 28 days after the notice has been advertised, to vary or discharge the order made,
- 47 3 in the case of each bankruptcy and liquidation, that
- (a) the costs of complying with a request of the committee or creditor for an account of the Applicant's administration should be an expense of the insolvency proceedings,

- (b) the fact that the creditors have the right to object and make representations to the Secretary of State in respect of the Applicant's release within 28 days after the notice has been advertised, and
- (c) the fact that the Applicant will be entitled to apply to the Secretary of State for his release within 42 days after the notice has been advertised
