The Directors present their Annual Report to the member together with the Financial Statements for the year ended 31 December 2020.

Business review

The principal activity of the Company was to hold investments as nominee on behalf of investors investing in the Limited Partnerships forming Doughty Hanson & Co V, a Fund of which the parent undertaking, Doughty Hanson & Co V Limited is the managing General Partner. The Fund was wound up on 24 February 2021 and a decision was made to dissolve the company.

As such the non-statutory Financial Statements have not been prepared on a going concern basis and have been prepared on a realisation basis.

Strategic Report

The Company qualifies as a small company in accordance with the Companies Act 2006 and as such a 'Strategic Report' has not been included within these Financial Statements.

Results

The Company received no fees for acting as a nominee and all costs were incurred by the parent company. Accordingly, the Company made neither a profit nor loss during the year. It is not anticipated that there will be any change to this state of affairs in the foreseeable future.
