### ORDER

UPON THE APPLICATION of Stephen Anthony John Ramsbottom  
AND UPON READING the evidence on the Court file  
IT IS ORDERED THAT:

1. Such of the matters listed in the attached Schedules which are proceeding in any court other than the High Court be transferred to the High Court solely for the purposes of this Application and thereafter be transferred back to the original court.
2. Pursuant to Section 298(1) of the Insolvency Act 1986 ("the Act") Stephen Anthony John Ramsbottom ("Mr Ramsbottom") of Deloitte LLP, 3 Rivergate, Temple Quay, Bristol BS1 6GD be removed from office as trustee in bankruptcy in respect of the individuals listed in Schedule 1 attached to this Application.
3. Pursuant to Section 303(2) of the Act Robin David Allen ("Mr Allen") of Deloitte LLP, 3 Rivergate, Temple Quay, Bristol BS1 6GD be appointed as trustee in bankruptcy of the individuals listed in Schedule 1 with immediate effect.

4. Pursuant to Paragraph 88(1) of Schedule B1 to the Act Mr Ramsbottom be removed from his office as joint administrator of those companies listed in Schedule 2 attached to this Application.
5. Pursuant to Paragraphs 63 and 91(1) of Schedule B1 to the Act Mr Allen be appointed as joint administrator of the companies listed in Schedule 2 with immediate effect.
6. Pursuant to Paragraph 88(1) of Schedule B1 to the Act Mr Ramsbottom be removed as joint administrator of those companies listed in Schedule 3 attached to this Application.
7. Pursuant to Paragraphs 63 and 91(1) of Schedule B1 to the Act Richard Michael Hawes ("Mr Hawes") of Deloitte LLP, 3 Rivergate, Temple Quay, Bristol BS1 6GD be appointed as joint administrator of the companies listed in Schedule 3 with immediate effect.
8. Pursuant to Section 108(2) of the Act Mr Ramsbottom be removed as joint liquidator of those companies listed in Schedules 4 and 5 attached to this Application.
9. Pursuant to Section 108(2) of the Act Mr Allen be appointed as joint liquidator of those companies listed in Schedules 4 and 5 with immediate effect.
10. Pursuant to Section 108(2) of the Act Mr Ramsbottom be removed as joint liquidator of those companies listed in Schedule 6 attached to this Application.
11. Pursuant to Section 108(2) of the Act Mr Hawes be appointed as joint liquidator of those companies listed in Schedule 6 with immediate effect.
12. The Respondents do within 28 days of the sealing of this Order give notice to all creditors of whom they are aware in that period of such removal and the new appointment, such notification to be by way of advertisements placed in the London Gazette, which advertisements shall constitute sufficient notice to all creditors, except where the appointment was made as trustee in bankruptcy, notice shall be sent to the bankrupt.
13. Such notice to be in the same or substantially in the same form as the draft advertisements annexed at Schedule 7 to this Application or with such other modification as the circumstances of any particular case shall require.
14. The costs of this Application be borne proportionately by each of the matters listed in the attached Schedules provided that in no case shall the total of such remuneration, costs and expenses (including VAT) exceed 10 per cent of the value of the realisable assets in each particular matter.

15. There be general liberty to apply to any creditor of the individuals or companies referred to in the attached Schedules within 28 days of the advertisement appearing in the London Gazette to vary or discharge this Order.
