Principal activity, business review and future developments

The Company has no principal activity. In prior years, the principal activity of the Company was to commercialise the international traffic to the BBC.com website. The Company has not traded during the year to 31 March 2022.

The Company is exempt from the requirement to prepare a Strategic report by virtue of it qualifying as a small company as defined by the Companies Act 2006.

The ownership of BBC Global News Limited (the Company's immediate parent) changed from BBC Commercial Holdings Limited (which changed its name on 1 April 2022 to BBC Commercial Limited) to BBC Studios Distribution Limited with effect from 1 July 2021.

The profit for the year ended 31 March 2022 was £nil (2021: £nil).

No dividends were approved or paid in the year (2021: £nil).





Notes to the financial statements

1 Accounting policies

A summary of the Company's principal accounting policies is set out below. These accounting policies have been applied consistently throughout the current and preceding years to items considered material to the financial statements.

1a Basis of preparation

BBC.com Limited is a company incorporated in the United Kingdom under the Companies Act. The address of the registered office is given on page 3. The nature of the Company's operations and its principal activities are set out in the Directors' report on page 2.

These financial statements were prepared in accordance with FRS 101 (Financial Reporting Standard 101) 'Reduced Disclosure Framework' as issued by the Financial Reporting Council.

The financial statements have been prepared under the historical cost basis.

As permitted by FRS 101, the Company has taken advantage of the following disclosure exemptions:

1b Going concern

Although the Company is not immune from the effects of the current economic environment, the directors believe the Company is well placed to manage the risks effectively, and has adequate resources to continue in operation for the foreseeable future. As a result the going concern basis has been adopted in the preparation of the financial statements.

The intermediate parent company, which heads the smallest group in which the financial statements of the Company are consolidated, is BBC Commercial Limited.
