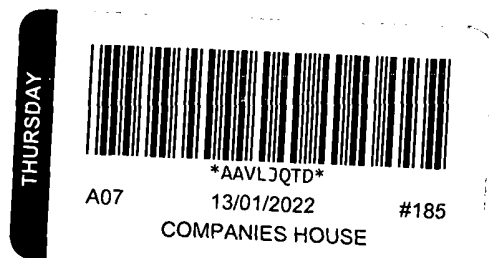



1 Statutory information
