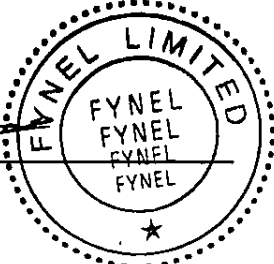
DIRECTORS

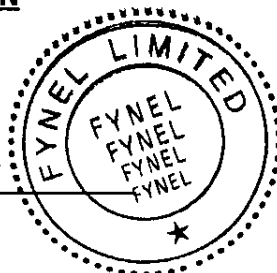

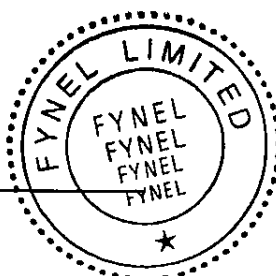
