Notes to the accounts

1.0 Accounting policies

1.1 Basis of preparation of financial statements

These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts.

The accounts have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities, preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and with the Charities Act 2011.

1.2 Reconciliation with Generally Accepted Accounting Policies

These are the company's first set of financial statements prepared under FRS 102. The financial statements for the year ended 28 February 2016 were prepared under Generally Accepted Accounting Policies. In preparing the financial statements the directors considered whether in applying the accounting policies required by FRS 102 the restatement of comparative items was required. Following a review no restatements were required.

1.3 Incoming resources

All incoming resources are recognised when the charity becomes entitled to the resources, it is probable that the income will be received, and the amount can be measured reliably.

Grants and donations are only included in the SoFA when the general income recognition criteria are met.

1.4 Donated services and facilities

Donated services and facilities are included in the SoFA when received at the value of the gift to the charity, provided the value of the gift can be measured reliably.

The value of services provided by volunteers has not been included in these accounts.

1.5 Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

1.6 Resources expended

Liabilities are recognised where it is more likely than not that there is a legal or constructive obligation committing the charity to pay out resources and the amount of the obligation can be measured with reasonable certainty.

All expenditure is accounted for on an accrual basis. All expenditure directly related to the provision of advice services is included within charitable expenditure. Other costs incurred have been allocated between fundraising and publicity and management and administration as appropriate.

1.7 Tangible fixed assets and depreciation

Fixed assets are included at cost. Depreciation is provided at rates calculated to write off the cost less residual value of each asset over expected useful life, as follows;
