2. DIRECTOR'S ADVANCES, CREDITS AND GUARANTEES

During the year, Mrs S H Wilson increased her loan to the company. As at 31 March 2022, the company owed her £65,274 (2021: £42,529). This balance represented the maximum amount outstanding during the year and the loan is interest free and repayable on demand.

Also during the year, the company paid rent amounting to £3,589 (2021: £3,589) as a result of utilising office space within her home.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 31 March 2022.

The members have not required the company to obtain an audit of its financial statements for the year ended 31 March 2022 in accordance with Section 476 of the Companies Act 2006.

The director acknowledges her responsibilities for:
