Operating expenses were covered by the funds from the company members.

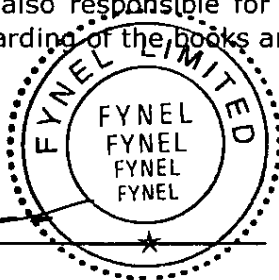
DIRECTORS

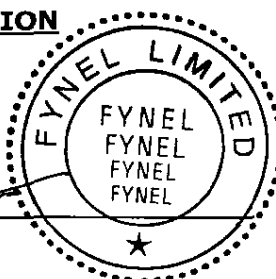

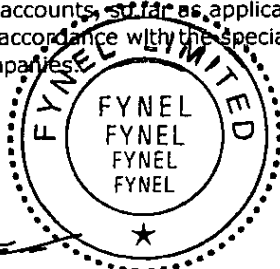
