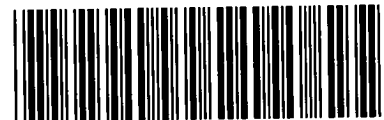

During the year Mr P Taylor made a loan to the company of £145,000 Which interest will be charged from 15 November 2019 at 1% above base rate.


For the year ending 30 April 2019 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.
