#### 6. Controlling party

The Company's immediate parent company is Indian Restaurants Limited, which is controlled by Cinnamon Collection Limited. Its ultimate parent company is Invest Co 1 Limited, which is incorporated in the United Kingdom.

The largest and smallest group in which the results of the Company are consolidated is that headed by Invest Co 1 Limited.
