Retail Merchant Group Limited is wholly owned by RMS HolCo Ltd (company number 10597461), which is in turn wholly owned by Salt Pay Europe Ltd., a company registered in England and Wales under company number 12951319, with its registered office at Third Floor, 20 Old Bailey, London, United Kingdom, EC4M 7AN.

Salt Pay Europe Ltd is wholly owned by Salt Pay Co Ltd, a company registered in the Cayman Islands under number HS-353341, and has its registered office at Intertrust Corporate Services (Cayman) Limited, One Nexus Way, Camana Bay, Grand Cayman KY1-9005, Cayman Islands.

Salt Pay Co Ltd is the parent company of the Salt Pay group, of which Retail Merchant Group Limited and RMS HoldCo Limited are a part of, and Salt Pay Co Ltd's accounts consolidates the financial statements of the group, including RMS HoldCo Limited and Retail Merchant Group Limited.

The consolidates financial statements of Salt Pay Co Ltd have been prepared under UK accepted IFRS, and its duly audited and signed version is attached hereto.
