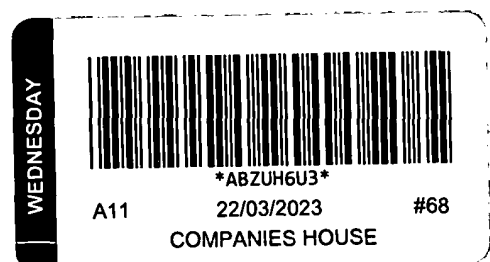

Annual report of the trustees for the year ended
30 June 2022

The trustees present their annual report together with financial statements for the period under review. The trustees have adopted Accounting and Reporting by Charities: Statement of Recommended Practice (SORP) and the Financial Reporting Standard applicable in the UK (FRS 102) in preparing the annual report and financial statements of the charity.

The attached financial statements cover the year ended 30 June 2022.

Objectives and activities

3CHH is a Worcester based local charity that offers subsidised holistic and complementary therapies to those in receipt of means tested benefit who would otherwise not be able to access such care. The charity provides a range of therapies that aim to empower clients to become more aware of their own physical and mental health and well being. These include mindfulness courses, massage, reflexology, Indian head massage and aromatherapy massage.

The objects of the charity, as stated in its governing document, are:

- to help relieve sickness and preserve and protect the good health of people by providing or assisting in the provision of complementary and alternative medicine including the provision of financial assistance.
- to advance education and research in all matters relating to complementary care by the provision of training and facilities to share information among interested healthcare professionals and the dissemination of the useful knowledge gained for the benefit of the public in general and in particular for people suffering from life threatening illness and their families, carers and friends.

The trustees have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission in exercising their powers and duties.

Achievements and performance

During the last twelve months 3CHH has continued its work in the local community by providing subsidised complementary therapies for low income families and those on means tested benefits. One of the principal activities has been the health and wellbeing courses that have been run throughout the year at our base at County House in the centre of Worcester. Spin offs from this are a mindfulness walking group and a support group.

3CHH holds monthly meditations and has a small nucleus of regular donations plus workshops organised by other practitioners as a means of generating income. It is also registered with the shopping web site Easyfundraising. 3CHH however remains reliant on securing funding from grants and benefactors to be able to continue its work.

In recognition of this 3CHH is currently recruiting additional volunteers and trustees with the relevant skills and expertise to help raise the awareness and profile of the charity to secure additional funding for its work can continue. 3CHH is also reaching out and trying to forge links with other charities, big and small.
