3 Counties Holistic Healthcare Limited Annual report of the trustees for the year ended 30 June 2023

The trustees present their annual report together with financial statements for the period under review. The trustees have adopted Accounting and Reporting by Charities: Statement of Recommended Practice (SORP) and the Financial Reporting Standard applicable in the UK (FRS 102) in preparing the annual report and financial statements of the charity.

The attached financial statements cover the year ended 30 June 2023.

Objectives and activities

3CHH is a Worcester based local charity that offers subsidised holistic and complementary therapies to those in receipt of means tested benefit who would otherwise not be able to access such care. The charity provides a range of therapies that aim to empower clients to become more aware of their own physical and mental health and well being. These include mindfulness courses, massage, reflexology, Indian head massage and aromatherapy massage.

The objects of the charity, as stated in its governing document, are:

- to help relieve sickness and preserve and protect the good health of people by providing or assisting in the provision of complementary and alternative medicine including the provision of financial assistance.
- to advance education and research in all matters relating to complementary care by the provision of training and facilities to share information among interested healthcare professionals and the dissemination of the useful knowledge gained for the benefit of the public in general and in particular for people suffering from life threatening illness and their families, carers and friends.

The trustees have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission in exercising their powers and duties.

Achievements and performance

During the past twelve months 3CHH has continued to offer subsidised complementary therapies for those on low-income families and means tested benefits. In addition to running health and wellbeing courses from our base at County House in the centre of Worcester we have also delivered a workshop, for which the charity received payment, at the Horizon Centre in Worcester on behalf of Community First and The Joy Project.

New relationships with other local charities are being fostered with the aim of collaboration and knowledge of the services these charities provide. The trustees have attended workshops, seminars and exhibitions to grow their knowledge base and further personal development.

3CHH continues to host monthly meditations as a regular source of funding and Easyfundraising generates a small income but remains reliant on securing funding from grants and benefactors to be able to continue its work.

The recruitment of additional volunteers and trustees with the relevant skills and expertise to help raise the awareness and profile of the charity to secure additional funding for its work is ongoing.
