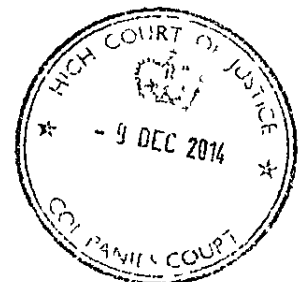

ORDER

**UPON THE AMENDED APPLICATION of Martin Weller ("the Applicant") dated
1 September 2014 AND UPON READING the Court file**

IT IS ORDERED that

- 1 The Application has permission to amend the Claim Form by adding Darren Wilson as a Respondent.

- 7 Each creditor and, in the case of members' voluntary liquidations, each member, shall have permission to apply to vary or discharge this Order in whole or in part within 28 days of being given notice of it,

8 Notice of this Order and of the permission to apply shall be given by being advertised in the London Gazette within 21 days of the date hereof;

9 There be no order as to costs.
