## **Directors' Report**

The Directors presents their Report and Financial Statements for the year ended 31 December 2012

### **Principal Activity and review of business**

The principal activity of LLP No 16 Limited ("the Company") is that of being a corporate member of Actis LLP. Under the terms of the Members' Agreement relating to Actis LLP, no profits of Actis LLP were allocated to the Company in the year ended 31 December 2012.

During the year, the company divested £64 (\$100) of the member's capital in Copper Partners LLP and acquired £61 (\$100) of the member's capital in Actis GP LLP, no income has been generated from these investments. The Company has not undertaken any other activity and consequently has neither profit nor loss for the year therefore a profit and loss account has not been presented.

The Company was incorporated on 2 July 2007, with a share capital of 1 £1 ordinary share issued at par. Its registered office is, 2 More London Riverside, London, SE1 2JT.

### **Auditor**

Pursuant to Section 487 of the Companies Act 2006, the auditor will be deemed to be reappointed and KPMG LLP will therefore continue in office.

### **Directors**

Actis Limited, Actis Nominee Limited, Ronald Edward Bell and Paul William Owers held office as directors of the company for the full year.

#### *Basis of preparation*
