Directors' Report For the year ended 31 December 2014

The directors present their report and the audited financial statements for the year ended 31 December 2014.

Principal activities

The Company's principal activity is that of an investment company. The Company has an uncommitted bank facility of £20m to enable it to provide bridge finance funding for investment by Rutland Fund II, a private equity fund which makes private equity and related investments. Further information is set out in Note 6.

Results

The Company made neither a profit nor a loss on ordinary activities for the year, after taxation (2013: £nil). The directors do not recommend the payment of an ordinary dividend (2013: £nil).

Parent and ultimate parent undertaking

The parent undertaking is Rutland Holdco Limited, which is registered in England. Rutland Holdco Limited is a wholly owned subsidiary of the ultimate parent undertaking, Rutland Partners LLP, which is also registered in England and is authorised and regulated by the Financial Conduct Authority. This is the parent undertaking of the only group to consolidate the accounts of the Company. A copy of the consolidated financial statements of Rutland Partners LLP may be obtained from Companies House in Cardiff, United Kingdom.

Directors

The directors, all of whom served during the year, are listed on page 1.

Directors' and Officers' liability insurance

Directors' and Officers' liability insurance cover is maintained by Rutland Partners LLP in respect of the Company's directors and officers.

Auditor

KPMG LLP have expressed their willingness to continue as Auditor.

Taxation

The Company is considered to be a close company under the provisions of the Income and Corporation Taxes Act 1988.

The directors who held office at the date of approval of this directors' report confirm that, so far as they are each aware, there is no relevant audit information of which the Company's auditor is unaware; and the directors have taken all the steps that they ought to have taken as directors to make themselves aware of any relevant audit information and to establish that the Company's auditor is aware of that information.

Notes to the Financial Statements For the year ended 31 December 2014

1. Principal accounting policies

The financial statements have been prepared in accordance with applicable Accounting Standards in the United Kingdom.

(i) **Basis of accounting**

The financial statements have been prepared on the going concern principle on the basis that the shareholder has confirmed its financial commitment to the Company ensuring all obligations of the Company will be met as and when they fall in for the foreseeable future. The financial statements are prepared in accordance with the historical cost convention.

Deferred tax (ii)

Deferred tax assets and liabilities arise from timing differences between the recognition of gains and losses in the financial statements and their recognition for tax purposes. Deferred tax liabilities are fully recognised and deferred tax assets are recognised when it is considered more likely than not that the asset will be recoverable. Deferred tax assets and liabilities are recognised on an undiscounted basis.

2. **Employee information**

The Company had no direct employees during the year. The directors received no remuneration in respect of the Company but are Partners of and are remunerated by Rutland Partners LLP which provides administration services on behalf of the Company.

3. Result on ordinary activities before taxation

The Company incurs interest in respect of loans or guarantees committed under the bank facility, as set out in Note 6. The Company normally recovers all such interest from Fund II.

Audit fees for the year amounting to £2,600 were borne by Rutland Partners LLP.

The Company has in place an uncommitted £20m bank facility, expiring on 18 May 2015, which provides, inter alia, short term bridge finance to enable Rutland Fund II ("Fund II"), a private equity fund, to (i) make new investments or (ii) support portfolio investments with short term working capital facilities. Funds may be drawn down by way of bank loan and normally an equivalent amount is loaned to Fund II to meet its financing requirements. The Company may also provide bank guarantees under the facility in respect of bank and other facilities of portfolio investments of Fund II. Funds drawn down or guaranteed by the Company are secured on the undrawn commitments of certain limited partnerships in Fund II, and may be drawn down within two business days of notification to the bank. Bridging loans drawn have a maximum repayment term of three months but may be extended for up to a further three months and guarantees may be drawn for twelve months.

During the year guarantees totalling £20.0m expired and a further guarantee of £5.0m was issued and subsequently expired. At 31 December 2014, a guarantee of £7.0m was in issue, which expires on 31 December 2015.

The Company incurs expenses in the form of interest and guarantee fees in respect of bank loans drawn and guarantees issued under the facility. The Company normally recovers all such expenses from Fund II.
