## REDUCTION OF CAPITAL – SOLVENCY STATEMENT – 20 JULY 2021

(For the purposes of s642 and s643 of the Companies Act 2006)

### MACQUARIE HOLDINGS (UK) NO.1 LIMITED

(the “Company”)

This declaration is made in respect of the proposed reduction of the issued share capital of the Company.

It is proposed that the Company’s issued share capital be reduced from £330,000,000, divided into 330,000,000 ordinary shares of £1.00 each, to £50,000,280 divided into 330,000,000 ordinary shares of £0.151516 each, by reducing the nominal amount of each ordinary share from £1.00 to £0.151516 accordingly.



- (ii) The Company will be able to pay (or otherwise discharge) its debts as they fall due during the year immediately following the date of this statement.


