 - 32 to acquire and deal with and take options over any property real or personal including the Estate and any rights or privileges of any kind over or in respect of any property and to improve develop sell lease accept surrender or dispose of or otherwise deal with all or any part of such property and any and all rights of the company,
 - 33 to collect all rents charges and other income and to pay any rates taxes charges duties levies assessments or other outgoings charged assessed or imposed on or in respect of the Estate or any part of the Estate,
 - 3.4 to provide services of every description in relation to the Estate and to maintain repair renew redecorate repaint clean construct alter and add to the Estate and to arrange for the supply to the Estate of services and amenities and the maintenance of the same and the cultivation maintenance landscaping and planting of any land gardens and grounds comprised in the Estate and to enter into contracts with builders tenants contractors and others and to employ appropriate staff and managing or other agents;

- 3.16 to do all such other things as may be deemed incidental or conducive to the attainment of the company's objects or any of them.

- 4 The liability of the members is limited
- 5 Every member of the Company undertakes to contribute such amount as may be required (not exceeding £1) to the Company's assets if it should be wound up while he is a member or within one year after he ceased to be a member, for payment of the company's debts and liabilities contracted before he ceases to be a member, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributories among themselves.

ARTICLES OF ASSOCIATION of THE CHANTRIES MANAGEMENT COMPANY (STANMORE) LIMITED

PRELIMINARY

- Subject as hereinafter provided the Regulations incorporated in Table A set out in the schedule to The Companies (Tables A to F) Regulations 1985 shall apply to the Company.
- 2. Regulations 2 to 35 (inclusive), 38, 44, 46, 54, 55, 57, 59, 74, 83, 102 to 108 (inclusive). 109, 110, 112 to 114 (inclusive), 116 and 117 shall not apply to the Company but the Regulations hereinafter contained together with the remaining regulations of Table A shall, subject to the modifications hereinafter expressed, constitute the Regulations of the Company.

INTERPRETATION

- In Regulation 1 of Table A, the definition of "the holder" shall be omitted and there shall be inserted before the words "office" and "secretary" the word "the" and between the words "regulations" and "the Act" the words "and in any regulations adopting in whole or in part the same"
- 4. Expressions referring to writing shall, unless the contrary intention appears, be construed as including references to printing, lithography, photography and other modes of representing or reproducing words in visible form

MEMBERS

5. All persons who become flat owners or lessees of a flat within the property known as The Chantries, Uxbridge Road, Stanmore, Middlesex HA7 3LG ("the Estate") under a lease for more than 21 years shall be members of the Company. A person shall Lease to a member forthwith upon his ceasing to be the owner or lessee of such a lease. Wherever two or more persons are joint flat owners or lessees they shall for all the purposes of these Articles be deemed to constitute one member

NOTICE OF GENERAL MEETINGS

- An Annual General Meeting and an Extraordinary General Meeting called for the passing of a Special Resolution or a Resolution appointing a person as a Director shall be called by at least twenty one clear days' notice All other Extraordinary General Meetings shall be called by at least fourteen clear days' notice but a General Meeting may be called by shorter notice if it is so agreed:-
 - (a) In the case of an Annual General Meeting, by all the members entitled to attend and vote thereat; and
 - (b) in the case of any other meeting by a majority in number of the members having a right to attend and vote being a majority together holding not less than 95% of the total voting rights at the meeting of all the members

The Notice shall specify the time and place of the meeting and the general nature of the business to be transacted and, in the case of an Annual General Meeting, shall specify the meeting as such

The Notice shall be given to all the members and to the Directors and Auditors.

PROCEEDINGS AT GENERAL MEETINGS

- A resolution put to the vote of a meeting shall be decided on a show of hands unless before, or on the declaration of the result of, the show of hands a poll is duly demanded Subject to the provisions of the Act, a poll may be demanded:
 - (a) by the Chairman, or
 - (b) by at least two members having the right to vote at the meeting being present in person or by proxy

and a demand by a person as proxy for a member shall be the same as a demand by the member

VOTES OF MEMBERS

- On a show of hands every member present in person shall have one vote. On a poll every member present in person or by proxy shall have one vote. In the case of joint members the vote of the senior who tenders a vote whether in person or by proxy shall be accepted to the exclusion of the votes of the other joint members and seniority shall be determined by the order in which the names of the members stand in the register of the members.
- 9 The Subscribers to the Memorandum of Association shall be the first Directors of the Company

- 10. No person who is not a member of the Company shall be entitled to hold office as a Director and any Director who ceases to be a member of the Company shall forthwith cease to hold office as a Director Regulation 81 of Table A shall be modified accordingly.
- 11. No Director shall vacate office or be ineligible for reappointment as a Director nor shall any person be ineligible for appointment as a Director by reason only of his having attained any particular age

DIRECTORS EXPENSES

12. The Directors may be paid all travelling, hotel, and other expenses properly incurred by them in connection with their attendance at meetings of Directors or committees of Directors or general meetings or separate meetings of the holders of debentures of the Company or otherwise in connections with the discharge of their duties.

DIRECTORS GRATUITIES AND PENSIONS

13. In Regulation 87 of Table A there shall be inserted between the words "the Directors" and "may" the words "on behalf of the Company"

PROCEEDINGS OF DIRECTORS

In paragraph (c) of Regulation 94 of Table A the word "debentures" shall be substituted for the words "shares, debentures and other securities" in both places where they occur.

MINUTES

- The Directors shall cause Minutes to be made in books kept for the purpose -
 - (a) of all appointments of Officers made by the Directors, and
 - (b) of all proceedings at meetings of the Company, and of the Directors, and of committees of Directors, including the names of the Directors present at each such meeting.

NOTICES

16. The Company may give any notice to a member either personally or by sending it by post in a pre-paid envelope addressed to the member at his registered address or by leaving it at that address. A member whose registered address is not within the United Kingdom and who gives to the Company an address within the United Kingdom at which notices may be given to him shall be entitled to have notices given to him at that address, but otherwise no such member shall be entitled to receive any notice from the Company.

17. A member present, either in person or by proxy, at any meeting of the Company shall be deemed to have received notice of the meeting and, where requisite, of the purposes for which it was called

DISSOLUTION

18. Clause 5 of the Memorandum of Association of the Company shall have effect as if the provisions thereof were repeated herein.
