

#### 1. ACCOUNTING POLICIES

##### 1.1. Basis of preparation of financial statements

The full financial statements, from which these abbreviated accounts have been extracted, have been prepared under the historical cost convention and in accordance with the .....German..... tax law.

##### 1.2. Cash flow

##### 1.3. Turnover
