1. ATTENDING APOLOGIES AND DECLARATIONS OF INTEREST

Apologies were received from Tony Taylor, Susan White, Peter Wilson, John Robson, Agatha Kanyangu and John Hicks. There were no declarations of interest.

6. PROPOSED CHANGES TO THE ARTICLES OF ASSOCIATION

Chris requested the Board to consider item 6 on the agenda before moving on to other

business given the need to address two important issues connected with the Articles of

Association.

6.1 Article 42

Currently Article 42 set out limitations on the minimum and maximum number of

trustees permitted. In particular, the maximum number is set at nine. With Dave Wood

being appointed to the Board, this limit would be exceeded and it was therefore a

necessity to amend Article 42 to increase this limit.

Given that a number of additional appointments was likely in the near future the

trustees considered that the upper limit set out in Article 42 be increased to 15 thereby

providing sufficient flexibility for the Board to make further appointments without having

to revisit the Article 42 limitations in early course. It was agreed that the minimum

number should remain at 3.

Action. The Board unanimously resolved to amend Article 42 with immediate effect to

provide that the maximum number of trustees shall be 15 and that the amendment

should be registered with Companies House as required.

6.2 Article 78

The matter of alternatives to face to face meetings had been raised at earlier meeting

as Chris had indicated that he felt that the Board ought to have greater flexibility in how

they were able to hold meetings and thus minimise the possibility of quorum not being

able to be achieved. Chris reported to the Board that the matter was governed by

Article 78 which permitted alternatives to face to face meetings provided that all

participants could communicate simultaneously with one another.

After discussion it was agreed by the Board that while face to face meetings were

desirable in normal circumstances they should have the maximum permitted flexibility

to use alternative means should circumstances require.
